GENERAL TERMS and CONDITIONS ROOTS BAZAAR – AMSTERDAM ROOTS FESTIVAL 2025

Organization: Stichting Amsterdam Roots

Exhibitor: Is anyone who has registered as such and has received a written agreement for a market space.

Article 1 - Market space

The organization is responsible for placing the market stalls and where applicable the power connections. The exhibitor is only entitled to the assigned (numbered) stall and/or space/location, assigned by the organization.

The exhibitor regulations for Amsterdam Roots Festival form an integral part of the general terms and conditions (this document will be shared by the organization upon final confirmation of participation).

Article 2 - Damages

The organization is not liable for damages caused to the exhibitor, arising out of or together pending with the participation of the festival. Even if this damage is the result of visible or invisible defects in the market stalls (2A) or failure in the power supply (2B).

2A - The exhibitor is liable for any damage(s) to or loss of (parts of) the market stall or other goods supplied by the organization to the exhibitor.

2B - If you are in need of a power supply, you need to inform the organization in advance. There will be a power point present at reasonable distance. If, by any circumstances whatsoever, this power supply fails or does not meet the wattage you need, the organization is not liable. A remedy will be sought as soon as possible. The organization reserves the right to terminate a power connection with immediate effect if the exhibitor is taxed more heavily than conveyed, allowed and/or if defective equipment is connected.

2C - To guarantee the physical state of the park, gardens and to ensure the quality of the grass, it is not allowed to;

- Embed any objects in the ground.
- Hang objects in/on trees.
- Do not dig.
- No heavy objects outside the paved areas (for clarity, behind your rented stall/space you may not place any objects on the lawns).
- Vehicles are only allowed on the paved trails and/or assigned areas (during installation and dismantling).

Damages to the terrain will be charged to the exhibitor and a fine must be paid.

Article 3 - Equipment & Power points

3A - The equipment used by the exhibitor must be of decent quality and include an inspection sticker.

3B - The organization is responsible for creating a requested connection within a radius of 25 meters from the market stall. The exhibitor is responsible for bringing the necessary reel.

3C - Bringing a private generator or alternative power source is not allowed.

3D - The organization is not responsible for any failures due to brought equipment. If as a result, multiple stands suffer from the failure, the organization will determine if the device can continue to be used.

3E - Reels must always be fully unwound. Looping of reels or splitting blocks is not allowed.

3F - All reels and divide blocks used must be covered, to prevent moisture coming in.

Article 4 - Liability

The exhibitor is always responsible and liable for all activities he deploys during the festival and indemnify the organization for claims by third parties in the broadest sense, arising out of or in connection with his participation in the festival. The exhibitor is obliged to close an adequate liability insurance to cover for any damage(s) caused to persons or property of third parties or to the organization.

4A - The organization is not liable for breakage, theft or damage, and/or lost sales in any form.

Article 5 - Sales

The exhibitor is not allowed to sell/promote articles other than defined in the contract. If when entering the Bazaar, it is revealed that the offering differs from your reported industry and merchandise, it can lead to total or partial evacuation of the stand. In this case, a refund of the stand fee is not possible.

5A - The exhibitor is, in any case, not allowed to sell or offer drinks to the public, whether for payment or not. Exceptions only possible with written permission of the organization.

5B - Sales are only to take place on Sunday the 6th of July 2025 from 13:00 until 22:00 o'clock.

Article 6 - Cars

It is not allowed to park cars on the festival site. Loading and unloading can only be done by the organizations indicated times and roads.

Article 7 - Advertising

The exhibitor is not allowed to advertise in any way (other than the brand name of the private enterprise) during the festival.

Article 8 - Sustainability & Waste

8A: The exhibitor is not allowed to give plastic materials, such as trays, cups, dishes, jars, bags, cutlery etc. to the public for the use / use of the food, drinks or products. The packaging used by the exhibitor must be compostable (no foil or aluminum foil allowed).

8B: The exhibitor is obliged to clean up his or her assigned space and the space directly around it and deliver the rented market stall in the original condition. Waste must be packaged in bags or boxes and deposited in the appropriate garbage containers.

8C - Amsterdam Roots is obliged to hand in all its waste separately (at a kilo price) and will hire special waste bins for this. If the exhibitor wants to use the organization's waste processing, this can be done for a fee of €55 by handing in the already separated waste to the organization at the end of the bazaar. The non-food exhibitor can also choose to take his waste with him and throw it away himself.

Article 9 - Compliance with the made agreements

If the exhibitor acts contrary to the provisions stated in these terms and conditions, the organization is entitled to immediately remove the exhibitor from the festival site without this resulting in any claim for compensation from the exhibitor. The exhibitor is liable to the organization for any resulting damage.

Article 10 - Cancellation of the Festival

If the organization decides that Amsterdam Roots Festival will not be able to take place, the agreements between the organization and exhibitor are automatically dissolved without the exhibitor being entitled to compensation or any kind of advancement, with the understanding that stand fees and deposits paid will be refunded in full.

AMSTERDAM ROOTS FESTIVAL

Article 11 - Oral agreements

Oral agreements in addition to or deviating from the participation confirmation and/or these terms and conditions are not legally valid.

Article 12 - Payments

By registering your company/organization for participation, the exhibitor agrees to a sales commitment, (when participation has been confirmed by Amsterdam Roots Festival) and agrees to receiving invoices of the requested facilities. The payment of the received invoice must be made within 14 days, after date. Without payment the contract will not be finalized and exhibitor is not permitted to sell anything on the festival.

Article 13 – Cancellation of market space

Cancellations, after participation has been confirmed, can only be done in writing (via e-mail) until 01-06-2025 at the latest with a refund of the stand fee and any deposit. If the exhibitor cancels after 01-06-2025, the organization is forced to charge 50% of the rate. If the exhibitor cancels after 17-06-2025, the organization will charge 100% of the rate.

Article 14 - General terms and conditions

In all cases where these terms and conditions do not provide, the organizations decisions are binding.
